### SUGGESTED MOTION

**I move to approve the amendment of Exhibit B to Resolution No. 2017-0008 reflecting only tax for operation and maintenance.**

### DISCUSSION

On June 26, 2017, the District Board voted to adopt the 2018 Budget of the Rancho Sahuarita Community Facilities District by adoption of Resolution No. 2017-0008. The Exhibit B that was attached to the Resolution when it was prepared set the tax rate at \$4.99 per \$100.00 assessed value. This rate was used because the CFD planned to issue debt, and the higher tax rate was necessary to pay the debt payments.

Right before distribution of the packet, the developer notified the District that it was withdrawing its consent to the bond issuance. Therefore, the Finance Department revised Exhibit B to the Resolution to reflect the tax rate at \$.30, for operation and maintenance only. Due to the rush, the Law Department submitted the old Exhibit B to the Clerk's Office, reflecting the erroneous higher tax rate.

If passed, this item will replace Exhibit B to Resolution No. 2017-0008 with a corrected version reflecting only the \$.30 operation and maintenance tax.
