Chairman Trospen opened the public hearing.

Dylan Parry, Planner, presented the staff report. Staff recommended that the Commission forward a recommendation for approval to Town Council.

Ms. Walker, SBA on behalf of Verizon Wireless, gave a brief presentation that addressed the suggestions of alternate sites for the Tower. She noted that the other sites did not allow for full use of the proposed tower and some of the suggested sites were too close to other existing towers.

Commissioner Woodward asked what steps would be made to assure continued maintenance of the tower. Ms. Walker assured that any terms that are agreed to for maintenance would be carried out. Commissioner Woodward suggested that a conditions to secure the maintenance of the tower be added to the motion.

Joseph Scheaffer, resident of Valle Verde del Norte, was in opposition of the tower. Mr. Scheaffer stated that a cell tower should not be put up in a residential area. Terry Scheaffer, resident of Valle Verde del Norte, was also in opposition of the tower.

Chair Trospen closed the public hearing and asked for a motion.

Commissioner Barrett made the motion to forward a recommendation to the Town Council and requested that staff add a condition for maintenance of the tower. Vice Chair Reilly 2nd the motion. MOTION CARRIED 4-1
